Our team is further supported by experienced legal assistants across both FD&D and P&I, ensuring strategic, responsive guidance and drawing on external expertise only when needed.

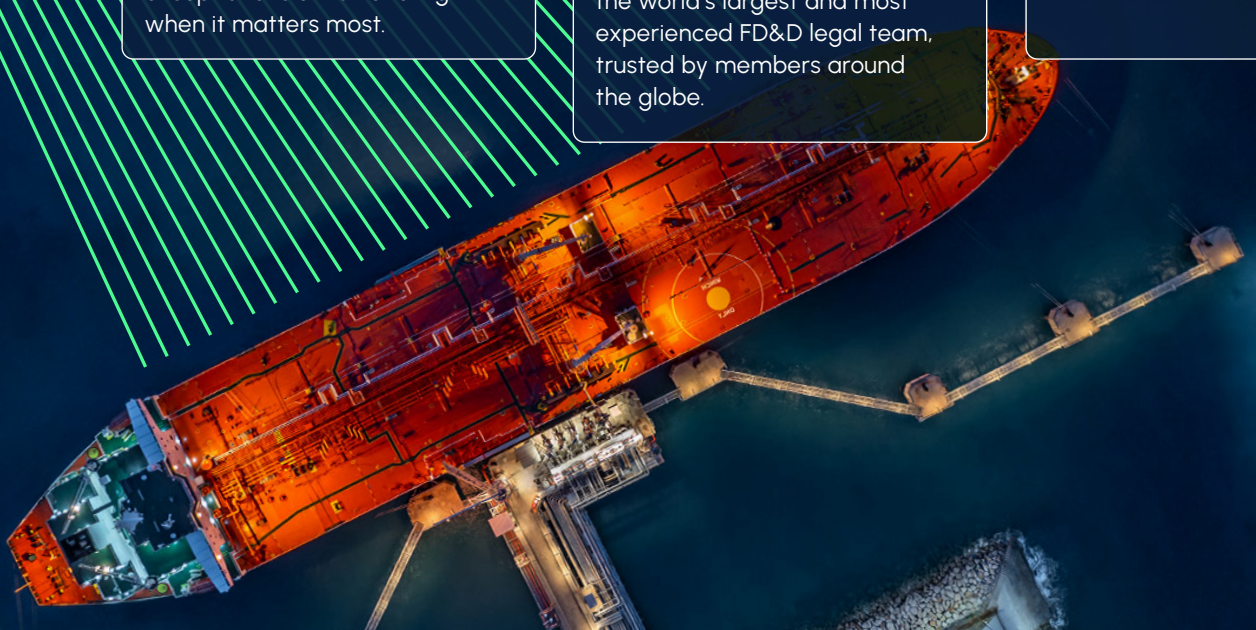
